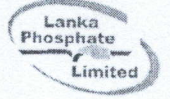



 - iii. Particle size Distribution: 100 to 150 Microns

 - (d) Delivery Terms: Ex-factory
