The method of payment of the non-refundable deposit will be in cash. The Bid shall be valid up to **17th March 2025**.
4. All Interested Bidders who have purchased bidding documents are allowed to inspect the MI-171 Helicopters at SLAF Base Katunayake from **07th October 2024 to 17th November 2024** between 0900 hrs to 1500 hrs on every working day.

Completed bid proposal must be couriered/ delivered to the address below, marked with Tender Identification Number on or before the stipulated time and date mentioned in above para 1 and late bids will be rejected. Bids will be opened immediately after the closing of the bids in the presence of the bidders/ bidders' representatives who choose to attend the Bid Opening, in person at the address below as per the referred time and dates mentioned above. No bidder or his representative will be permitted to attend the bid opening after the bid closing time.
